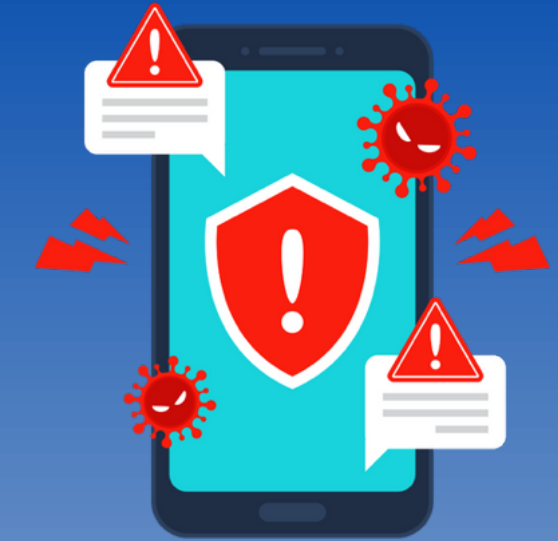
## Identify
